

Blevins School Board Minutes

April 11, 2011

Administration Office

The regular meeting of the Blevins School Board was called to order by President Melony Ford on Monday, April 11, 2011 at 7:00 p.m. in the administration office. Board members present: Melony Ford, Laura Massey, Carl McGill, Paul Noesser and Jimmy Rhodes. Others in attendance: Superintendent Billy Lee, Pat Loe, Jeffrey Steed and Lisa Doss. Minutes to the March 14, 2011 meeting were approved as presented.

Melony Ford made a motion to approve the financial report as presented. The motion passed with a 5-0 vote.

Jimmy Rhodes made a motion to approve the Personnel Policy Committee request to combine sick and personal leave into annual leave effective July 1, 2011. The motion passed with a vote of 5-0.

Melony Ford made a motion to accept the lawn service bid of Keith and Terri Steed for \$830 each service for the 2011-2012 school year. The motion passed with a 5-0 vote.

The board tabled a decision regarding copier contracts until next month when representatives from TLC Office Systems and Vanco will present revised proposals to the board.

Paul Noesser made a motion to remove the option to rent the gymnasium from wording in the Public Use of Facilities document. The motion passed with a vote of 5-0.

Paul Noesser made a motion to approve the 2011-2012 academic calendar proposal two by the Personnel Policy Committee and designated graduation day as May 4, 2012.

Laura Massey made a motion to purchase the following cafeteria equipment: an 18 pan non-insulated cabinet warmer for \$1410 and an 80 quart standing mixer for \$8121.36. The motion passed with a 5-0 vote.

Jimmy Rhodes made a motion to approve the Title 1 Technology budget. The motion passed with a vote of 5-0.

Melony Ford made a motion to set an expulsion hearing for Monday, April 18, 2011 at 7:00 p.m. The motion passed with a 5-0 vote.
