

## Blevins School Board Minutes

July 19, 2010

### Administration Office

The regular meeting of the Blevins School Board was called to order by President Joan Noesser on Monday, July 19, 2010 at 7:00 p.m. in the Administration Office. Board members present: Melony Ford, Tim Estes, Richard Snell, and Jimmy Rhodes. Members absent: Jay Smith and Carl McGill. Others in attendance: Superintendent Billy Lee, Jeffrey Steed, Pat Loe, and Cindy Lee. See attached list for others present. Prayer was led by Tim Estes and the pledge was said by all.

Minutes to the Regular meeting on June 14, 2010 and minutes from the special meeting on June 21, 2010 were approved as presented.

A motion was made by Richard Snell to accept a bread bid from Flower's Bakery for the 2010-2011 school year. Motion passed with a vote of 5-0.

Tim Estes made a motion to accept a milk bid from Borden. Motion passed with a vote of 5-0.

Tim Estes made a motion to accept a bid from Electrocoat of \$4450 to paint the lockers in the High School. Motion passed with a vote of 5-0.

A motion was made by Richard Snell to purchase services at a cost of \$2500 from APSRC for the 2010-2011 school year. Motion passed with a vote of 5-0.

A motion was made by Tim Estes to accept a bid of \$5400 from Michael Esada for painting the inside of the gym. Motion was passed with a vote of 5-0.

Jay Smith respectfully resigned his position on the Blevins Board of Directors. The resignation was accepted with regret by Board President Joan Noesser.

#### Personnel:

- A. Richard Snell made a motion to accept the resignation of classified aide Marilyn Davis. Motion passed with a 5-0 vote.
- B. A motion was made by Tim Estes to rehire certified teacher Charlotte McCauley to fill vacant 4<sup>th</sup> grade position; McCauley next name on RIF list. Motion passed with a 5-0 vote.

Joan Noesser made a motion to leave the option open for Superintendent Billy Lee to hire a 1/8 day certified librarian and/or certified math instructor if needed. Motion passed with a 5-0 vote.

A motion was made by Tim Estes to pay Richard Allen \$2900 for 12 additional days that he worked during the month of July. Motion passed with a vote of 5-0.

Tim Estes made the motion to hire 2 students for 4 weeks to help with preparing for beginning of school. Motion passed with a 5-0 vote.

Melony Ford made a motion to allow the purchase of a used bus on/or about \$50,000 with the school mechanics approval of the selection. Motion passed with a vote of 5-0.
