

Blevins School Board Minutes

October 11, 2010

Administration Office

The regular meeting of the Blevins School Board was called to order by Vice President Richard Snell on Monday, October 11, 2010 at 7:00 p.m. in the Administration Office. Board members present: Tim Estes, Melony Ford, Laura Massey, Carl McGill and Paul Noesser. Others in attendance: Superintendent Billy Lee, Pat Loe, Jeffrey Steed and Lisa Doss. See attached for others present. Prayer was led by Tim Estes and the pledge was said by all.

Minutes to the September 13, 2010 meeting were approved as presented.

A motion was made by Paul Noesser to elect the following school board officers for the 2010-2011 year: Melony Ford, President; Richard Snell, Vice President; Tim Estes, Secretary-Treasurer. The motion passed with a 6-0 vote.

Paul Noesser made a motion to make a resolution to deed the Emmet tornado shelter building to the Emmet Alumni Association. The motion passed with a vote of 6-0.

A motion was made by Tim Estes to accept two bids from Jimmy White to replace K-4 windows as follows: \$18,000 for exterior windows; \$9500 for interior windows. The motion passed with a 6-0 vote.

Board member Jimmy Rhodes arrived at 7:25 p.m.

Paul Noesser made a motion to accept a bid of \$4875 from Glen Young to pour concrete slabs under the high school pavilion and for a basketball court. Motion passed with a vote of 6-0. Board member Laura Massey excused herself from the room during the vote due to a familial conflict of interest.

A motion to approve the 2010-2011 ACSIP as submitted was made by Paul Noesser. Motion passed with a vote of 7-0.

A motion was made by Melony Ford to set a minimum sale price of the storage house across from the post office at \$8000 as is, with buyer to assume all expenses. Motion passed with a 7-0 vote.

Personnel:

- A. Richard Snell made a motion to accept the resignation of custodian Carrie Yingst. Motion passed with a 7-0 vote.
- B. Melony Ford made a motion to move Carolyn Watts to full time employee with benefits, and to replace the 4 hour custodial position. Motion passed with a vote of 7-0.
- C. A motion was made by Richard Snell to change the duties of teacher Sharon Ricks to Technology Specialist effective 10-11-10. Motion passed with a 7-0 vote.
- D. Tim Estes made a motion to rehire Stephanie Clark, next on the RIF list, as 5-6 Literacy teacher. Motion passed with a vote of 7-0.

Melony Ford tabled the decision to move Charlie Hutchison to the varsity cheerleading squad from the junior varsity squad pending more information.

A motion was made by Tim Estes to name Superintendent Billy Lee acting construction manager of Blevins Public Schools administration building project. Motion passed with a 7-0 vote.
