

Blevins School Board Meeting

October 12, 2015

The regular meeting of the Blevins School Board was called to order at 7:00 p.m. by Vice President Richard Snell on Monday, October 12, 2015 in the administration office. Board members present: Jeremy Banister, Ted Bonner, Carl McGill, Mike Parker and Richard Snell. Members absent: Laura Clark. Others in attendance: Superintendent Billy Lee, Jeffrey Steed and Lisa Doss. See attached for others present. Prayer was said by Richard Snell and the Pledge of Allegiance was said by all.

Ted Bonner motioned to approve the September minutes. Motion passed with a 5-0 vote.

Ted Bonner motioned to approve the September financial report. Motion passed with a 5-0 vote.

Mike Parker motioned to elect Richard Snell as school board president. Motion passed with a 4-0 vote with Richard Snell abstaining.

Richard Snell motioned to elect Mike Parker as school board vice president. Motion passed with a 4-0 vote with Mike Parker abstaining.

Richard Snell motioned to elect Laura Clark as school board secretary. Motion passed with a 5-0 vote.

Ted Bonner made a motion for Justice West to fill the vacant Zone 1 school board seat. Motion passed with a 5-0 vote. Justice West joined the meeting at 7:25 p.m.

Richard Snell motioned to approve ASBA Law 5-4 regarding School Improvement Teams. Motion passed with a 6-0 vote.

Ted Bonner motioned to approve the purchase of a lift for the special education bus from Nationwide Bus Parts in the amount of \$5934.50. Motion passed with a 6-0 vote.

Ted Bonner motioned to postpone a motion indefinitely regarding the installation of a bus motor by Big Rig Trucking and Trailer in the amount of \$2000. Motion passed with a 6-0 vote.

Ted Bonner motioned to approve an addendum to the student handbook regarding cell phone use. The addendum reads as follows: 1st violation—confiscation of device (returned to parent, 1 week); 2nd violation—confiscation of device (returned to parent, 1 week) and Saturday School; 3rd violation—confiscation of device (returned to parent, 1 week) and 3 days OSS; subsequent violations—same as 3rd violation. Motion passed with a 6-0 vote.

Richard Snell motioned to hire Beverly Meeks as a bus driver. Motion passed with a 6-0 vote.

Board President Richard Snell called for an executive session at 8:15 p.m. Meeting resumed at 8:31 p.m.

New Zone 1 board member Justice West took an official oath of office.
