Justice West motioned to hire Billie Lacefield as the pre-k aide. Motion passed with a 7-0 vote.

Ted Bonner motioned to hire Susan Henderson as an elementary aide. Motion passed with a 7-0 vote.

Justice West motioned to hire Dylan Fulton and Blake Lucas as summer laborers. Motion passed with a 7-0 vote.
