The regular meeting of the Blevins School Board was called to order at 6:59 p.m. by President Melony Ford on Monday, June 9, 2014 in the administration office. Melony Ford motioned to approve the May minutes. Motion passed with a 6-0 vote.

Melony Ford motioned to approve the financial report. Motion passed with a 6-0 vote.

Ted Bonner motioned to approve a two year contract with Liles Therapy, Inc. for PT, OT, PTA, COTA, Medicaid and speech therapy. Motion passed with a 6-0 vote.

Ted Bonner motioned to accept a bid dated 5-21-14 from the City of Emmet to purchase Emmet School property sections 4,5,7,8 as is for \$11,000. Motion passed with 6-0 vote.

Paul Noesser motioned to approve the purchase of a cafeteria dishwasher from Central Restaurant Products for \$16,225. Motion passed with a 6-0 vote.

Melony Ford motioned to approve the proposed 2015-2016 budget. Motion passed with a 6-0 vote.

Ted Bonner motioned to accept the resignation of Jeremy Banister. Motion passed with a 6-0 vote.

Paul Noesser motioned to hire elementary teacher Kayla Plyler. Motion passed with a 6-0 vote.

Ted Bonner motioned to hire elementary aide Misty Waters. Motion passed with a 6-0 vote.

Paul Noesser motioned to hire Janet Gordon as a long term substitute teacher for \$125 per day. Motion passed with a 6-0 vote.

President Melony Ford called for an executive session at 7:24 p.m. The meeting resumed at 8:10 p.m.

Superintendent Billy Lee made a recommendation to reassign Lisa Doss as elementary principal. Ted Bonner motioned the reassignment; motion passed with a 6-0 vote.

Superintendent Billy Lee made a recommendation to table reassignment of Pat Loe to math coach pending outcome of DHS hearing. Ted Bonner motioned to table the recommendation; motion passed with a 6-0 vote.

Paul Noesser motioned to approve ASBA insurance policy renewal in the amounts of \$28,268.28 for property and \$5597.82 for vehicles. Motion passed with a 6-0 vote.

Melony Ford motioned to accept the board resolution for Billy Lee to represent the Blevins School District in the sale of all school properties and the signing of all documentation related to the sale. Motion passed with a 6-0 vote.

Ted Bonner motioned to table a request by Cindy Heagwood for additional contract days or financial compensation for added technology duties. Motion passed with a 6-0 vote.
