

Blevins School Board Minutes

July 18, 2011

Administration Office

The regular meeting of the Blevins School Board was called to order by President Melony Ford on Monday, July 18, 2011 at 7:10 p.m. in the administration office. Board members present: Melony Ford, Laura Clark, Paul Noesser and Jimmy Rhodes. Others in attendance: Superintendent Billy Lee, Jeffrey Steed and Lisa Doss. See attached for others present. Prayer was said by Laura Clark and the pledge was said by all.

Minutes to the June 13, 2011 meeting were approved as presented.

Melony Ford made a motion to accept the financial report as presented. The motion passed with a vote of 4-0.

A motion was made by Melony Ford to hire Gene Hawk for a two year contract as facilities manager at \$3600 per year. The motion passed with a 4-0 vote.

Paul Noesser made a motion to accept a bid of \$19,500 from John and David Stallsworth to install gym bleachers and siding on bus shop buildings. The motion passed with a vote of 4-0.

Paul Noesser made a motion to accept a bid from Michael Esada to paint the K-6 library for \$725. The motion passed with a 4-0 vote.

Board member Carl McGill arrived at 7:32 p.m.

Jimmy Rhodes made a motion to accept a bid of \$12,750 from Michael Esada to prepare and paint the outside of the high school gym. The motion passed with a 5-0 vote.

A motion was made by Melony Ford to give Jobs Fund bonuses of \$811 to each certified employee and \$550 to each classified employee during the 2011-12 school year. The motion passed with a vote of 5-0.

Laura Clark made a motion to accept the following updates to the ASBA policy: 1.11, 1.16, 3.1, 3.6, 3.38, 3.40, 4.1, 4.2, 4.4, 4.5, 4.7, 4.8, 4.12, 4.13, 4.13f, 4.15, 4.25, 4.32, 4.35, 4.43, 4.47, 4.52, 4.53, 5.3, 5.4, 5.11, 5.20, 5.26, 6.5, 7.3, 7.6, 7.9, 8.26, 8.34. The motion passed with a 5-0 vote.

Melony Ford made a motion to accept the district handbook for 2011-12. The motion passed with a vote of 5-0.

The board went into executive session at 8:10 p.m.

The meeting resumed at 8:31 p.m.

Paul Noesser made a motion to renew ASBA contract at \$1250 per year. The motion passed with a 5-0 vote.
