Paul Noesser made a motion to accept the financial report as presented. Motion passed with a 5-0 vote.

Melony Ford made a motion to accept a bid for 2011-2012 senior girls' basketball uniforms from Southwest Sports in Arkadelphia. The motion passed with a vote of 6-0.

Jimmy Rhodes made a motion to retain the services of Vanco for copier services for the remainder of their contract. Motion passed with a 6-0 vote.

The board tabled a decision regarding concrete bids for the metal building (bus shop) pending additional information from the bidder.

Paul Noesser made a motion to accept a bid for \$8000 from Jimmy White to take down the metal building at Emmet and move it to the Blevins campus. Motion passed with a 6-0 vote.

Melony Ford made a motion to accept a bid for \$18,000 from Jimmy White to reassemble the metal building and add 20 feet to its dimensions including materials and labor. The motion passed with a vote of 6-0.

Tim Estes made a motion to accept four students from Delight through school choice for the 2011-2012 year. The motion passed with a 6-0 vote.

Melony Ford made a motion for the board to include administrators in receiving high priority district incentive bonuses. Motion passed with a vote of 6-0.

Paul Noesser made a motion for Jennifer Myrick and Andrea Woodruff to teach the ACT Summer Program at a cost of \$1846.99 the week of June 6-10, 2011. Motion passed with a 6-0 vote.

Tim Estes made a motion for the district to adopt the SWSC meal allowance for the Washington, D.C. trip only due to unexpected costs incurred. Motion passed with a 6-0 vote.
