## BLEVINS SCHOOL BOARD MINUTES May 10, 2010

## Computer Lab/Emmet Campus

The regular meeting of the Blevins School Board was called to order by President Joan Noesser on Monday, May, 2010 at 7:04 p.m., in the computer lab on the Emmet campus. Those board members present were: Joan Noesser, Tim Estes, Melony Ford, Jimmy Rhodes, Carl McGill and Richard Snell. Member absent was Jay Smith. Others in attendance were Superintendent Randy Treat, Billy Lee, Pat Loe and Shirley Treat. See list attached of others present. Melony Ford led the prayer and the pledge was said by all present.

Minutes to the April 12, 2010 regular meeting was approved with corrections. Financial report was given.

Student recognitions for both campuses were read by Superintendent Randy Treat. See list attached.

Donation of large piece of playground equipment to the City of Emmet was discussed. Motion was made by Tim Estes to donate the equipment to the city of Emmet. Motion passed with a vote of 6-0.

Blevins School District Board of Directors tabled the decision as to what to do with the concession stand equipment until next month.

Motion was made by Tim Estes to extend the Liles Therapy contract for the 2010-2011 school year with the price the same as the 2009-2010 contract.

ACT workshop proposed. See proposal attached. Motion made by Carl McGill to accept the proposal. Motion passed with a vote of 6-0.

Credit Recovery-see proposal attached. Superintendent Randy Treat recommended the board approve the proposal. Amanda Buck would be hired for 96 hours at \$11.60 per hour for a total of \$1,113.60. Tim Estes made motion to accept proposal as presented. Motion passed with a vote of 6-0.

- d. Superintendent Randy Treat recommended Chris Sweat be hired to teach Ag Leadership, Career Orientation, Chess and 4 classes of EAST. With a stipend of \$1,000.00. Carl McGill made motion to accept the recommendation. Motion passed with a vote of 6-0.
- e. Tim Estes made motion to offer the job as Blevins School District Superintendent to Billy Lee. Motion passed with a vote of 6-0.

Phase II of the RTTT, MOU is ready to be signed by Joan Noesser and Mr. Treat. Tim Estes made motion for approval for them to sign. Motion passed with a vote of 6-0.

Tim Estes made a motion to allow Head Start children ride the school busses since ABC students were allowed too. Motion passed with a vote of 6-0.

Tim Estes made a motion to hire Jay Conley to move the security system from Emmet to Blevins High School for \$2,175.00. Motion passed with a vote of 6-0.

Tim Estes made motion to hire Jay Conley to move the fire alarm system from Emmet to Blevins High School for \$3,230.00. Motion passed with a vote of 6-0.

Melony Ford made motion to accept the School of Choice for Paige and Taylor Dougan. Motion passed with a vote of 6-0

Superintendent Treat recommended hiring Connie McMorris for the Month of June to help with the cleaning in the school. Tim Estes made motion to accept recommendation. Motion passed with a vote of 6-0

Superintendent Treat recommended purchasing a 16 ft straight pull flat bed trailer for \$1,495.00 to facilitate the moving of equipment from Emmet to Blevins. Tim Estes made motion to purchase trailer. Motion passed with a vote of 6-0

Superintendent Treat reported with the paper we had left, that the 2 pallets donated from Dunbar was all that would be needed for the coming year.

Superintendent Treat recommended that board hire Nantez from Texarkana to bury fiber Optics between elementary and hi school in order to get trailer moved in and set for the amount of \$2,475.00. Tim made motion to hire Nantez. Motion passed with a vote of 6-0.

Carl McGill made motion to hire Jimmy White to build the IDEA kitchen between the 2 self-contained classrooms, for the amount of \$17,500.00. Motion passed with a vote of 6-0.

Richard Snell made motion to start the process of conveying the tornado/storm shelter room and parking lot to the city of Emmet. Motion passed with a vote of 6-0.

Destination Imagination wants money for gas. They do not want to take a bus on trip. Board had offered bus and gas. Board will pay for registration but not give money.
