A special meeting of the Blevins School Board was held on Thursday, June 3, 2010 at the administration office. President Joan Noesser called the meeting to order at 7:02 p.m. Board members present: Tim Estes, Melony Ford, Jimmy Rhodes and Richard Snell. Members absent: Carl McGill and Jay Smith. A motion was made by Richard Snell to retain Magnolia attorney Ryan Phillips to handle legal transfer of the Emmet storm shelter from Blevins Public Schools to the City of Emmet. Motion passed with a 5-0 vote.

Tim Estes made a motion to accept forty-six transfer students from Delight who have turned in school of choice papers, and the board passed the motion with a 5-0 vote. See attached list of names.

- E. Tim Estes made a motion to hire Scott Kelton as Blevins High School assistant principal, ½ AD, basketball coach, and one spring sport to be determined later on a 210 day contract for \$59,137. The motion passed with a vote of 5-0.
