

The monthly meeting of the Blevins School Board was called to order at 7:01 a.m. by Laura Clark on Monday, November 13, 2017 in the school administration building. Board members present: Laura Clark, Janet Banister, Cindy Parks, Carl McGill, and Blake Simmons. Others in attendance: Superintendent Billy Lee, Elementary Principal Pat Loe, and High School Principal Jeffrey Steed.

Prayer was led by Carl McGill and the Pledge of Allegiance was said by all.

Cindy Parks made a motion to approve the Report To The Public and the October 2, 2017 minutes. Motion seconded by Carl McGill. Motion passed with a 5-0 vote.

Blake Simmons made a motion to accept the financial report for October 31, 2017. Janet Banister seconded the motion. Motion passed with a 5-0 vote.

No Contract Disclosure Issues.

Blake Simmons made a motion to accept the ASBA Model Policy Agreement at a cost of \$2850.00 (three-year agreement). Motion seconded by Carl McGill. Motion passed with a 5-0 vote.

Cindy Parks made a motion to hold future school board elections in May of each year beginning in May 2018. Motion seconded by Carl McGill. Motion passed with a 5-0 vote.

Elementary Principal Report ----- Currently no out of school suspension options for K-5 students. No action by board at this time pending further research/review. Elementary also reviewing change from classroom assessment to interim assessment.

High School Principal Report ----- Currently completing first round of interim assessment of ACT Aspire scores. Ms. Myrick's leadership class recently involved in community service project (food drive for Hope in Action; cooked/served meals at Hope in Action).

Food Service Director (Angie Mitchell) gave program regarding guidelines followed by cafeteria: funding; bidding process; calorie/nutrition guidelines; portion control; etc.

Carla Narlesky presented letter to school board ---- read by Laura Clark per Ms. Narlesky's request. No board action taken.

Board went into Executive Session at 7:46 ----- executive Session dismissed at 8:08. No action taken.

Janet Banister asked if the school could set up e-mail address for each board member for school board related correspondence. Superintendent will review with Cindy Heagwood.

Laura Clark made a motion to appoint Carl McGill to fill the school board position in Zone 7 for the remaining 2017-2018 school year. Janet Banister seconded the motion. Motion passed with 5-0 vote.

Janet Banister made a motion to adjourn the meeting at 8:20 p.m. Blake Simmons seconded the motion. Motion passed with 5-0 vote.
