Melony Ford motioned to accept the January minutes. Motion passed with a 6-0 vote.

Richard Snell motioned to approve the new K-6 mission and vision statement. Motion passed with a 6-0 vote.

Ted Bonner motioned to hire Brianna Allgood to be the 7-12 special education teacher for the 2014-2015 school year. Motion passed with a 7-0 vote.

President Melony Ford called for an executive session at 7:45 p.m. The meeting reconvened at 9:04 p.m.

Ted Bonner made a motion to renew the high school principal contract, renew the curriculum coordinator contract, and table renewal of the elementary principal contract for 2014-2015. Motion passed with a 7-0 vote.

Mike Parker motioned to change the high school principal multiplier to 1.50, elementary principal multiplier to 1.45, curriculum coordinator multiplier to 1.40, and drop the teacher travel, band director, Century 21 coordinator and degreed bookkeeper multipliers. Motion passed with a 7-0 vote.
