Cindy Parks made a motion to approve the minutes of the May 7, 2018 and May 14, 2018 board meetings. Chandra Dixon seconded the motion. Motion passed with 5-0 vote.

Cindy Parks made a motion to accept the financial report for May 31, 2018. Carl McGill seconded the motion. Motion passed with 5-0 vote. (NOTE: Laura Clark will review the proper way to handle all "negative balances" on the activity report before June 30, 2018 with Tiffany Hastings).
